Clarification No. 2

- 1) The execution period of the contract is of six (6) months from the date of the last signature on the contract.

As requested in the Technical Offer Form, as part of the technical offer, bidders are to upload 'A Graphic Work Schedule (Gantt Chart) in relation to the six (6) month period allowed as Execution of the Contract under Article 19 of the Special Conditions'.

However, Section 1, Clause 1.2 in the tender document should read:

*'The place of installation and commissioning of the supplies shall be the Ministry for Gozo, St Francis Square, Victoria, the time-limits for the execution of the contract shall be six (6) months from date of last signature on contract, and the INCOTERM²⁰²⁰ applicable shall be **Delivery Duty Paid (DDP)**.'*

Section 2, Article 13.1 in the tender document should read:

'The time limit for the execution of the works under this contract will be five (5) months from the date of last signature on contract. The order to start works will allow 2 weeks' notice. The 2 weeks' notice shall not be considered as part of the execution period...'
