Best Christmas Decorated Window or Façade Competition.

Terms and Conditions

1. This competition is available for residences in Gozo only.
2. Participants' windows or house façade must be decorated for Christmas and New Year by Tuesday, 24th November 2020 and the decorations shall not be removed until Tuesday, 6th January 2021.
3. The Ministry for Gozo will inform the Participants by e-mail with the date & time of the morning and evening visits by the Judges.
4. Judging is conducted through points awarded for appeal, originality, artistic creativity and overall presentation. The points for this competition will be distributed as follows:
 - a) Appeal – Max. 20 points
 - b) Originality – Max. 25 points
 - c) Artistic creativity – Max. 25 points
 - d) Overall presentation – Max. 30 points
5. In all cases, the judges' decision shall be final and no further correspondence shall be considered.
6. Two participants - One participant from the Best Decorated Façade category and one participant from the Best Decorated Window category - will be chosen for every village.
7. The winners will be announced on Thursday, 7th January, 2021.
8. The prizes are as follows:
 - a) Best Decorated Façade - €350

b) Best Decorated Window - €250

9. Eligible entrants must be:

- a) 18 years or older;
- b) Owners and/or tenants of the property applied for this competition;
- c) Applying for residential property decoration only.

10. Applications submitted later than Sunday, 13th December 2020 will not be accepted.

11. Participants agree to have their decorated property photographed for publicity purposes.

12. Participants who use illegal materials will be automatically disqualified.

13. The Ministry for Gozo is not responsible for any adverse consequences including accidents, which may arise from these decorations and the participant agrees to shoulder the risk involved, if any.

14. Charity collection boxes and collections for personal gain of the participant are strictly prohibited and will lead to disqualification from the competition.

15. Participants are not to block any passages, rights of way, make use of any outside electrical poles or trespass any property outside their boundary for any purpose of their display. Rental properties should seek written permission from their landlords before applying for this competition.

16. Participants must apply for only one category - Best Decorated Façade category or the Best Decorated Window category .

17. Properties which have not been submitted through the competition entry form will not be eligible for the Best Decorated Window or Best Decorated Façade competition categories.

18. Failure to comply with the Terms and Conditions of Entry will lead to automatic disqualification.

19. The Terms and Conditions are subject to change.

Termini u Kundizzjonijiet

1. Din il-kompetizzjoni miftuħa biss għal residenzi ġewwa Għawdex.
2. It-tieqa jew faċċata tad-dar trid tkun imzejjna għall-Milied u l-Ewwel tas-Sena mit-Tlieta, 24 ta' Novembru 2020 sal-Erbgħa, 6 ta' Jannar 2021.
3. Il-Ministeru għal Għawdex se javża lill-partecipanti permezz ta' e-mail bid-data u l-ħin taż-żjara kemm ta' filgħodu kif ukoll ta' filgħaxija li se ssir mingħand il-Ġurija.
4. L-evalwazzjoni se tkun fuq bażi ta' dehra, oriġinalità, kreattività artistika u preżentazzjoni. Il-punti għal din il-kompetizzjoni se jiġu mqassma hekk:
 - a. Dehra – Massimu 20 punt
 - b. Oriġinalità – Massimu 25 punt
 - c. Kreattività Artistika – Massimu 25 punt
 - d. Preżentazzjoni – Massimu 30 punt
5. F'kull każ id-deċiżjoni tal-Ġurija se tkun finali u l-ebda tip ta' korrispondenza mhu se tiġi kkunsidrata.
6. Minn kull raħal se jiġu magħżulin żewġ partecipanti - wieħed mill-kategorija ta' L-Isbaħ Tieqa u wieħed mill-kategorija ta' L-Isbaħ Faċċata tad-Dar.
7. Ir-rebbieħa se jiġu mħabbra nhar il-Ħamis, 7 ta' Jannar 2021.
8. Il-premijiet se jkunu:
 - a. L-Isbaħ Faċċata - €350
 - b. L-Isbaħ Tieqa - €250

9. Il-partecipanti eliġibbli jrid ikollhom/ikunu:

- a. Minn 18-il sena 'l fuq;
- b. Sidien jew kerrejja tal-propjetà li se tiġi użata fil-kompetizzjoni;
- c. Propjetà residenzjali biss.
